### **Fees and Dues:**

New members, except retirees, must pay a one-time **\$25.00** application fee in addition to annual dues. For corporate memberships the fee is assessed per group, not individual.

Sales tax is charged on dues.

Dues must be paid in full upon approval by the Tulsa Press Club Board of Directors.

Dues will automatically renew each January.

### **Cancellation of Dues:**

Article IV, Section 4 of the Tulsa Press Club By-Laws:

If a member requests that their membership be cancelled, this member must submit written notification to the board thirty (30) days prior to cancellation date. Upon which, all dues and accounts must be paid in full and membership will be terminated. There will be no refunds for memberships paid in full.

### **Charging Privileges:**

For all house charges, a current credit card must be maintained on each membership(s). All monthly charges, including automatic membership renewals, will be cleared monthly via the credit card on file.
